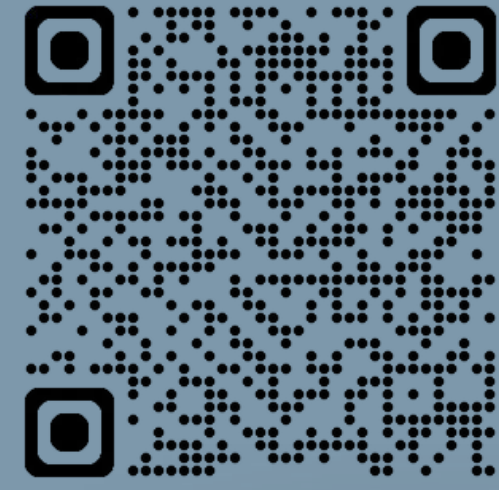
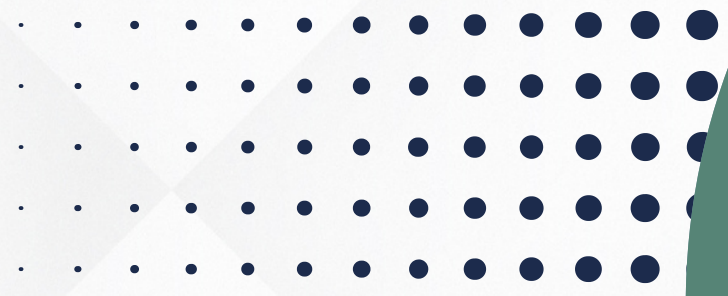

SENIOR SERVICES

Empowers seniors to maintain their health and nutritional well-being and allows seniors to remain in their homes.

13,062

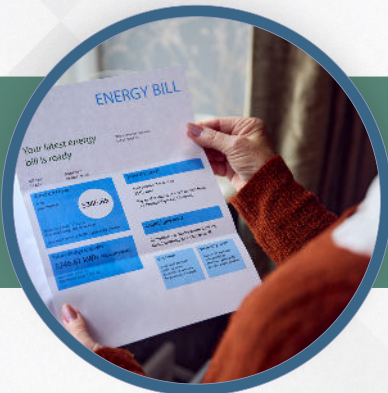
Hot, nutritious meals were served to **233** seniors in a congregate setting.

ENERGY ASSISTANCE

Heats homes during the winter season and extends budgets for low income households.

458

Households received assistance with their utility payments.

Households received additional crisis energy assistance.



WEATHERIZATION

Lowers energy bills for low-income people.

22

Households had their homes weatherized.

31

Households received home conservation services funded through the local utility companies.

19

Households received energy related repairs, such as furnace replacements.



HOUSING REHAB LOANS

Improves living conditions for low-income households and preserves quality, affordable housing.

HEAD START & EARLY HEAD START

Empowers families & young children for school readiness and provides Head Start families with comprehensive services.

TRANSPORTATION

Ensures people get to their medical and dental appointments, Senior Dining and other locations to meet essential needs.

Rides were provided for **122** people through the Volunteer Driver Program.



OUTREACH AND EMERGENCY SERVICES

Supports people through a crisis and allows them to utilize their limited income until they reach stability.

160

Households received crisis financial assistance for transportation, utilities or medical needs impacting **495** individuals.

492

Households accessed food Rushord and Preston food shelves, impacting **1,176** individuals.

548

Households were provided information and referrals.

148

Households were provided with holiday/Christmas presents during the holiday season impacting **401** individuals.

54

Households were assisted with rent or mortgage payments or motel vouchers to prevent homelessness, impacting **102** individuals.
