- * **Medical, Dental, Nutrition & additional comprehensive services are offered** for the wellbeing of the child & family; promoting healthy living for the whole family.

- * We offer a **two-generational approach** to our services including support for the parents & guardians to strengthen the family and achieve goals.
 - * We offer **support for strong parent-child relationships**.
 - * Family members can **volunteer. Parents are involved in program decisions.**
 - * **Teachers and Educators** have a **full set of credentials** related to child & family development.
 - * Our services are offered through research-based curriculum.
 - * Head Start plans **services based** on an annual **community needs** assessment to learn what the current and greatest needs are in the area.
 - * **Our priority is at-risk families.**

The mission of the Head Start program states that we are committed to building bright futures by enriching young children, ages Birth—5 years old, and empowering their families. Comprehensive services and community opportunities support healthy families.

Semcac's Head Start Services

The program is guided by over 1700 federal performance standards, based on proven research of what works for children & their families. We have services for ages birth-to-five years. Children with special needs are met with individualized care.



Classrooms

Classroom setting services, referred to as Center-Based services, are offered 4 days per week. Head Start for preschool age children (3 - 5 years) operates September - May/June. Early Head Start toddler classrooms (Austin and Winona only) operate year-round. We have part-day and full-day centers, depending upon the site.

Home-based

Home-based educators travel, on a weekly basis, to the homes of enrolled pregnant women and homes with children ages birth - 3 years. Additionally, every 2 weeks there is a socialization event at the Center nearest the family.

Semcac Head Start Stats (average over 5 years)

55% of families were **single-parent**, mostly women.

65% of enrolled **working families meet income eligibility** based on **100%** federal poverty guidelines (for example, a family of 4 earns \$25,750/ year).

52% of parents and guardians have a **high school diploma or less education**.

9 homeless or foster children are served each year.

18% of children served had **special needs**.

24% of children are dual language learners.

Who is eligible to enroll in Head Start?

Eligibility criteria are based primarily on the family income and the child's age as well as whether a child has a disability. Indicators of a child and/or family at-risk, such as a single parent family, a parent with special needs, referrals from social services or public health, and living in a location that would prevent them from experiencing preschool, will be considered. Income eligibility is determined according to the Department of Health and Human Services Federal Poverty Guidelines, released annually. **At least 10% of the total number of enrollment opportunities will be made available to children with disabilities.**

Head Start is a second home for kids. Families feel comfort knowing their kids are safe.
